Note

San Miguel de Allende is a municipality in the eastern region of Guanajuato, Mexico. The area was the site of a Chichimeca village called Izcuinapan prior to Spanish colonization in the early 16th century. The current town was founded in 1555 by Bernardo Cossin, and named San Miguel el Grande. By the mid-18th century it was one of the largest settlements in New Spain, with a population of over 30,000 residents. San Miguel was central to the Mexican War of Independence in the early 19th century; the town was renamed San Miguel de Allende in 1826 in honor of revolutionary hero Ignacio Allende.

Custodial history

Donated to the library in the early 1970s by Col. A.A. Greene (deceased 1999), a former faculty member in the Spanish department at Trinity University.

Scope and content

Collection of 123 documents concerning the San Miguel de Allende region of Mexico, dating from 1645-1897, and including but not limited to town records, church records, liquor taxation records, and liquor production records. Items in this collection were cataloged by Dr. Alida Metcalf, former professor of history at Trinity University, and her undergraduate students in 1995.

Arrangement

Documents have been arranged in six series based on the document type, as identified by Dr. Metcalf's students: Correspondence (Series 1), Financial (Series 2), Legal (Series 3), Literary (Series 4), Printed (Series 5), and Miscellaneous (Series 6). Within these series, documents have been arranged in chronological order. The identification numbers assigned by Dr. Metcalf during her class project remain on the individual folders, allowing items to be cross-referenced to the documentation produced by her students. An additional series (Series 7) contains Documentation related to the historic manuscripts and Dr. Metcalf's cataloging project.
